- This offer is open to Australian residents (*1st Prize Winner must be over 18 to be eligible to enter this competition - refer to Clause 14) who purchase one of the eligible Uniden UHF Narrow Band transceivers from a participating Australian retail outlet during the promotion period. Employees of Uniden, members of their immediate families and /or agencies associated with this promotion, and staff of the participating retail outlets are ineligible to enter the promotion.
- The Promotion period commences 15th July 2011 and concludes 15th October 2011. Uniden must receive all correctly completed official entry coupons by last mail on 31st October 2011. Official entry coupons received after this date will be deemed ineligible to participate in the offer.
